



## XIT Continues to Expand Fiber Optic Network ...

XIT Communications recently announced that XIT's fiber optic construction crew and contractors are hitting the streets and alleys of Sunray, Texas, hard in the next few months to complete its fiber optic overbuild of the City.

In addition to XIT's truck, residents in Sunray will see trucks and equipment with 3CK Utilities and JL Backhoe Service logos on them.

The City of Sunray is divided into five different PONS A, B, C, D, and E. In communication terms, "PONS" stands for "Passive Optical Network," which is a fiber optic network technology that allows a single fiber from a service provider to deliver broadband connections to multiple end users simultaneously, using only passive optical splitters without any active electronic equipment along the signal path, making it cost-effective and efficient for delivering Internet access to homes and businesses.

PON B is nearly completed in Sunray ... with 3CK Utilities working currently in PON C.

XIT is also in the process of negotiating contracts with Gulf Shore Tel-Com, based out of Athens, Texas, for construction of fiber optic

Lemon Poppyseed Bread by Linda Vermedahl

- 1 package lemon style cake mix (not pudding style)
- 3 ounce package instant lemon pudding
- 4 eggs
- 1 cup water
- ½ cup oil
- ¼ cup poppyseeds
- ½ cup powdered sugar
- 1 tablespoon lemon juice



Preheat oven to 350 degrees. Spray Pam or grease and flour 2 loaf pans. Mix all ingredients but powdered sugar and lemon juice in a mixing bowl. Beat on high for 4 minutes. Pour into prepared loaf pans and bake for 45 minutes. To make glaze mix together powdered sugar and lemon juice. Pour glaze over hot bread while in pans. Cool in pans for 10 minutes, then remove.

# What is CPNI?

Customer Proprietary Network Information is data considered classified by the FCC. This information may include your charges, services, telecommunications history, and other account information. In other words, CPNI entails private information about your service with us.



XIT Rural Telephone Cooperative, Inc. and XIT Communications are required by the FCC (The Federal Communications Commission, a government entity) to attach CPNI information to our customer accounts. This provides a safeguard for our customers against unauthorized charges and fraud.

XIT takes every precaution to ensure we provide the greatest protection to our customers and their personal information. You can help us by making sure your CPNI information is up to date at any given time. Our Customer Service Clerks and Representatives are required to request that your shared secret password or the answer to your shared secret question be provided when you call in to gain information or make changes to your account. You should give this information to anyone who is authorized to access information from your account or make changes on your behalf.

At your earliest convenience, please give us a call to ensure we have the proper CPNI safeguards set up for you!

lines in Sanford/Fritch and Stinnett, Texas. This construction will be divided into three projects ... starting with Project I in the areas around Sanford and Lake Meredith. Project II will include the City of Fritch, and Project III will be the buildout of the City of Stinnett.

XIT Communications has completed fiber optic projects in Dalhart, Stratford, Hartley, Channing, Boys Ranch, Vega, and its rural service areas of Bunkerhill, Coldwater, Kerrick, Lautz, Middlewater and Texline.

Completed projects outside XIT's current serving area include the Beverly Hills Addition ... a short distance north of Borger, Texas.

These projects are not short in duration ... construction, drops, splicing, electronics and more. All a lengthy process.

XIT looks forward to adding more Panhandle towns to its service area.
